## RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT

In consideration of being permitted to participate in any way in the Wolverine Sport Club (WSC) sponsored bicycling, speedskating, cross country skiing and other activities (Activity), I, for myself, my personal representatives, assigns, heirs, and next of kin:

Acknowledge, agree, and represent that I understand the nature of WSC Activities and that I am qualified, in good health and proper physical condition to participate in such Activity. I further acknowledge that the Activity may be conducted over public roads and other facilities open to the public during the Activity and upon the hazards of which traveling are to be expected. I further agree and warrant that if at any time I believe the conditions to be unsafe, I will immediately discontinue further participation in the Activity.

Fully understand that: (a) bicycling, speedskating, cross country skiing, and other WSC Activities involve risks and dangers of serious injury, including permanent disability, paralysis and death (Risks); (b) these Risks and dangers may be caused by my own actions, or inactions, or the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the "Releasees" names below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at the time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity.

Hereby release discharge, and covenant not to sue the Club, their respective administrators, directors, officers, volunteers, any sponsors, advertisers, and if applicable, owners, and lessors of premises on which the Activity takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise; and I further agree that if, despite this Waiver of Liability, Assumption of Risk, and Indemnity Agreement I, or anyone on my behalf, makes a claim against any of the "Releasees", I will indemnify, save, and hold harmless each of the "Releasees" from any litigation expenses, attorney fees, loss, liability, damage, or cost which may occur as a result of such claim.

I have read the agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without and inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held invalid, the balance notwithstanding shall continue in full force and effect.
